## CHARLESTON-SAVANNAH TOUR ★ JUNE 10 – 14, 2020

(The background is the Avery Research Center in Charleston)

### DAY 1 ★ WEDNESDAY, JUNE 10, 2020 ★ Dallas / Charleston ★ (D) ★ (continued)

Dr. Marvin Dulaney, former director of the Avery Research Center. This historic secondary school, known as the Avery Normal Institute, trained Black students for professional careers, leadership roles, and served as a hub for Charleston's African-American community from 1865 to 1954. Afterwards, group will check into the **Embassy Suites – Downtown Historic Charleston** for a two nights stay. After a few minutes to relax, tour members will leave for a privately chartered **"Welcome to Charleston" Narrated Tour and Buffet Dinner Cruise** aboard the **Carolina Belle**.

### DAY 2 ★ THURSDAY, JUNE 11, 2020 ★ Charleston ★ (B, Box Lunch) ★

After breakfast at the hotel, we will be joined by a very knowledgeable local Tour Guide. A full day of sightseeing includes a visit to the **Boone Hall Plantation**, one of America's oldest working plantations that has continually grown crops for over 320 years. The plantation is known for "Avenue of Oaks" an allee of over a half mile along the entry drive up to the house planted with 44 southern live oaks on either side. Tour members will tour the plantation house, slave cabins (which were occupied by sharecroppers well into the 20<sup>th</sup> century) and experience a "Gullah presentation."

*Our tour continues to Sullivan's Island, one of the 5 Gullah Islands.* It is estimated that in the 1700s some 40% of West African slaves entered through Low Country ports such as Sullivan Island. 80% of African-Americans have an ancestor who came through Charleston, SC.

Tour members will see **"Bench by the Road"**, a project that was launched on February 18, 2006, on the occasion of Toni Morrison's 75th Birthday.

In 1990 Dr. Marvin Dulaney (who will be travelling with us) as director of the Avery Research Center was instrumental in erecting a historical marker entitled, **"This is Sullivan's Island."**

Additional touring includes sites such as **Catfish Row; Gravesite for Samuel Goats Small** (known for the story of *Porgy & Bess*); and a visit to the **Old Slave Mart Museum**. The return to our hotel is approximately 5:00 pm. to enjoy the hotel's complimentary happy hour and light buffet. The balance of the evening and dinner is on your own tonight.

### DAY 3 ★ FRIDAY, JUNE 12, 2020 ★ Charleston / St. Helena Island / Savannah ★ (B) ★

After breakfast at the hotel, with bags packed and ready to go, our motorcoach leaves Charleston for St. Helena Island, home of the **Penn Center** where MLK wrote his famous "I Have a Dream Speech."

Afterwards, group will enjoy lunch on their own before continuing to Savannah.

Upon arrival in Savannah, group will visit the **Ralph Mark Gilbert Civil Rights Museum**, known as Georgia's Official Civil Rights Museum.

Approximately 5:00 pm, tour members will check into the Hilton Hotel – Savannah Historic District for the next two nights. The remainder of the evening is free and dinner is on your own.

### DAY 4 ★ SATURDAY, JUNE 13, 2020 ★ Savannah ★ (B, L, D) ★

After breakfast at the hotel, leave for a full day of touring in Savannah includes a visit to the **Pin Point Heritage Museum** on Moon River (a chance to experience Gullah Geechee culture first hand); **Second African Baptist Church** (site of the Forty Acres & a Mule Proclamation and where MLK preached his "I Have a Dream Sermon" that was repeated during the famous march on Washington DC in 1963); **Owens-Thomas House & Slave Quarters Museum** and slave burial grounds.

Approximately 4:30 pm, group will return to the hotel to freshen up for dinner.

Tonight a **"Farewell 3 Course Dinner"** is included. You will learn the nuances of southern food with a cooking class hosted by **Chef Darin's Kitchen Table**. The menu features fried green tomatoes, shrimp and grits, dessert and more.

### DAY 5 ★ SUNDAY, JUNE 14, 2020 ★ Savannah / Charleston / Dallas ★ (B) ★

After breakfast at the hotel, with bags packed and ready to go, it's a leisure morning

**9:45 am** Church services at the **First African Baptist Church** (one block walk from the hotel).

Both free African Americans and slaves made the bricks and built the church at night after the slaves had labored in the fields. The church was the first building constructed of brick to be owned by African Americans in the state of Georgia. First African Baptist Church claims to be derived from the first black Baptist congregation in North America.

**OPTIONAL:** Church Service @ First Jerusalem Baptist Church (has a great choir that sings on the paddle boat)

**1:00 pm** Guided tour of the **First African Baptist Church** showcasing where runaway slaves were hidden.

**2:30 pm** Leave Savannah for the Charleston Airport (approximately 2 hours drive)

**6:25 pm** Departure on SW Airlines from Charleston to Dallas Love Field.

**10:45 pm** Arrival in Dallas
